

NOTICE No. 02/2020 1° EYE CHANNEL INTERNATIONAL MUSIC FESTIVAL

The Brazilian Society of Ophthalmology and EYE CHANNEL website makes public the announcement of the 1st Music Festival to be held online from Septemper 04 to October 02, 2020.

1- PRELIMINARY PROVISIONS

1.1 The "*1st EYE CHANNEL INTERNATIONAL MUSIC FESTIVAL*" is a project developed by the Eye Channel portal (<u>www.eyechannel.com.br</u>) in partnership with the Brazilian Society of Ophthalmology (SBO).

1.2 The Festival aims to stimulate musical and cultural practice, with the proposal of entertain ophthalmologists, amateur musicians from all over the country.

2. THE OBJECTIVES OF THE FESTIVAL

2.1 Create a space for new artists, bands and musical groups belonging to the medical community to exhibit their work;

2.2 Encourage and create musical culture among ophthalmologists;

2.3 The purpose of this campaign is to cheer up colleagues a little, with something that certainly calms us, which is music. During this period we are working under various anxieties, which may bring depression and discouragement to everyone. Music is certainly something that will please everyone and make us aware of our musical talents among fellow ophthalmologists.

3. PARTICIPATION REQUIREMENTS

3.1 The following may participate: Doctors and Ophthalmology Residents.

3.2 External members may participate in the videos even if not linked to ophthalmology, in the composition of groups, as long as one of the members complies with the requirements of item 3.1 ;.

3.3 Registration is free of charge, and the candidate can participate in the following categories:

3.3.1 Individual: Only 1 (one) candidate belonging to the medical community (only residents or ophthalmologists can enroll in this category).

a) Individual means: 1 (one) solo performance, which may have some acoustic and / or electronic support instrument to accompany.

3.3.2 Collective (group): more than 1 (one) candidate, with the participation of members of the external community being possible.

a) Collective means: 1 (one) group presentation, starting with 2 (two) people, with at least 1 (one) ophthalmologist, 1 (one) or more instruments for the presentation can be used.

3.4 Members of the Organizing and Judging Committee of the event, as well as their spouses, partners or relatives up to the third degree, will not be able to participate;

3.5 Candidates who send the video in Pout Pourri format will not be accepted, that is, several songs on a single track played one after the other.

3.6 Videos will not be accepted where advertisements from other brands, events or similar appear on the screen.

3.7 The video must have a minimum length of 1:30 min and a maximum of 6:00 min to be accepted.

3.8 By attending the selection, participants must declare to know and accept the rules of the present regulation.

4. REGISTRATION

4.1 Enrollment will be made until August 30, 2020, by email: <u>contato@eyechannel.com.br</u>.

4.2 Upon enrollment, the participant must send full name and city of residence.

4.3 Each entry can submit up to 02 (two) songs, however only 01 (one) will be selected to participate in the contest.

4.4 Right after registration deadline, proposals will be forwarded to the Organizing Committee for the approval and selection process.

4.5 The Organizing Committee is composed of five members, Alexandre Paratela Gama, Belquiz Nassaralla, Edna Almodin, Jordana Sandes e Júlia Jordana Novaes.

4.6 The Brazilian Society of Ophthalmology and EYE CHANNEL, including the Organizing Committee, are not responsible for technical problems at the time of registration as well as the uploaded videos.

5. HOMOLOGATION AND SELECTION

5.1 In this process it will be verified if the candidate fulfilled all the criteria described in the notice.

5.1.1 The approval will be published on the EYE CHANNEL website (<u>www.eyechannel.com.br</u>), on September 03, 2020, through specific notice.

5.1.2 Proposals outside the criteria stipulated in this notice will not be accepted.

6. THE EVENT

6.1 The videos will be exposed according to the schedule established by the Organizing Committee.

6.1.1 At the discretion of the Organizing Committee, the approved videos will have their initial exhibition on September 04, 11, 18 and 25, 2020.

6.1.2 After the initial screening, the videos will be available for viewing on the official event page (<u>www.eyechannel.com.br</u>).

6.2 The Festival will be held online (<u>www.eyechannel.com.br</u>), and the voting will be available to the public starting at 09pm on September 04 and ending at 11:59pm on the 01th of October 2020 (Brasilia time).

6.3 The final result will be published on October 02, 2020 on the official event page (<u>www.eyechannel.com.br</u>).

6.4 If there is a tie, the Individual entry category will prevail as a favorite.
